Additional duties of administrative educational nature, course development, or GSI supervision can be assigned and will follow L&S Guidelines.

## **Lectuers in-lieu of GSI**

Appointments of lecturers hired to do the work of a GSI in the Philosophy Department are calculated according to the following parameters for a 30% FTE appointment.

10.89% - 3 hours per week Lead Discussion Sections (3.63% x 3 hours)

16.53% - Other Assigned Duties - Discussion Sections (5.51% x 3 sections)

02.76% - .5 hours of Outside Prep (5.51% x .5 hour)

30.18%

Note: For lecturers acting as GSI's, the job expectation is to lead three hour-long discussion sections per week for up to 50 students, read and grade assignments, provide individual consultations in office hours, and attend three hours of lectures per week. A lecturer hired to perform the duty of one GSI position is not an instructor of record and leads discussion sections only. This work consistently requires an extensive amount of outside preparation, and includes one half hour devoted to outside preparation.

## **Advising by Lecturers**

Lecturers may be approached by undergraduates or graduates for formal supervision outside of their lecture courses or proseminars, under headings including, but not limited to, 98, H195, 198, 199, and 299. Before agreeing to such supervision, lecturers should get written approval from the department chair, which should also clarify how, if at all, the supervision will be compensated.

There is no expectation that lecturers will be willing to take on such additional supervision, and lecturers should feel free to decline. However, there is also no expectation that the department will approve the supervision or provide compensation.

In general, the department chair will approve compensation only for supervision that makes a specific contribution to satisfying the requirements for a Berkeley philosophy degree. No supervision will be compensated unless specifically approved in advance by the department chair.

Combinations of courses at various IWCs may result in a total appointment < 100% and less than 6 year.
